2. Payments

Terms and Conditions : The remaining balance must be paid no later than **7 days before your arrival**. We accept payments by credit card (Visa, MasterCard), bank transfer, and other secure payment methods available on our site. Any bank fees for international payments are the responsibility of the customer.

Terms and Conditions : Prices listed on our website are in euros and include local taxes unless otherwise specified. We reserve the right to modify prices at any time. However, once your reservation is confirmed, the price of your stay will remain fixed and not subject to changes.

3. Cancellations and Modifications

Cancellations or modifications to your stay must be made in writing (email) and may incur fees depending on the time before your arrival date.

- Cancellation more than 30 days before arrival: full refund of the deposit.
- Cancellation between 30 and 14 days before arrival: the deposit will be retained, but a credit valid for 12 months will be offered.
- Cancellation less than 14 days before arrival: no refund of the deposit, and the full amount may be charged if we are unable to rebook the accommodation.

Terms and Conditions : In the event of **force majeure** (natural disasters, pandemics, official travel restrictions), we will do our best to offer a postponement or a refund, depending on the circumstances.

4. Check-In and Check-Out
